

ATTENTION BOWLERS

The **Illinois Women's 600 Bowling Club** is sponsoring a **Mail-o-graphic Tournament** the week of **March 23 through April 5, 2020**. The tournament is open to **ALL Illinois USBC Women** bowlers bowling in any certified league. This tournament is a fund raiser for the club and will supplement the Harriet L. Day Scholarship Fund which has awarded a scholarship to a female bowler continuing her education beyond high school. This year the club will award up to 2 scholarships. You can submit your best league score from any league on any night during the tournament. You may enter as many leagues as you bowl in as long as you pay a separate entry fee for each league. Each bowler may only cash once. Cost of the tournament is \$10.00 with $\frac{1}{2}$ of the entry fee going to the IW600BC and $\frac{1}{2}$ to the prize fund. \$4.00 of every entry fee will be allocated to the Scholarship Fund of the Bowling Club. Tournament Rules

1. This Tournament will be sponsored by the Illinois Women's 600 Bowling Club for IL USBC WOMEN BOWLERS.
2. This tournament will be conducted by submitting highest 3 game series total bowled in an USBC certified league during the dates of March 23, 2020 through April 5, 2020.
3. Entering Average will be:
 - a. 2018-2019 seasons highest USBC certified league average of 21 games or more.
 - b. If no 2018-2019 average, the highest USBC certified league average of 21 or more games from the 2019 summer season, if verified by the local association manager or BOWL.com.
 - c. Bowlers with neither of the above averages shall use the highest USBC certified league average of 12 or more games bowled by March 22, 2020, if verified by the local association manager or a copy of current league standing sheet showing average as of March 22, 2020.
 - d. Bowlers with none of the above averages bowl scratch.
4. USBC rules 319a-2, 319d and 319 3 are waived.
5. If more than 3 games are bowled in scheduled league play, the first 3 games will be used.
6. An entry with a separate entry fee may be submitted for each USBC certified league bowled in by a participant. An entrant may only cash once.
7. All scores must be bowled in an USBC certified league during league play and must be accompanied by a photocopy of the score sheet.
8. The prize fund will be returned 100% and will be based on a payout of 1 cash prize per every 5 entries.
9. Prize checks will be mailed by May 11, 2020.
10. An entry will be **“declared ineligible”** if the score verification form is returned without the needed verification of the league average sheet **AND** a copy of the league recap sheet.

FAILURE TO COMPLY WITH THE TOURNAMENT RULES WILL DISQUALIFY ENTRIES. CHECKS SHOULD BE MADE PAYABLE TO ILLINOIS WOMEN'S 600 BOWLING CLUB. A \$25.00 FEE WILL BE CHARGED FOR ALL RETURNED CHECKS IN ADDITION TO ANY BANK CHARGES. RESULTS WILL BE POSTED ON THE WEBSITE. IF YOU WOULD LIKE A COPY, PLEASE SEND A STAMPED ADDRESSED ENVELOPE ALONG WITH YOUR SCORES. IF YOU INCLUDE YOUR EMAIL ADDRESS, THE STANDINGS WILL BE EMAILED TO YOU.
